- 3) A non-refundable application fee of Ten (\$10.00) Dollars, made payable to Blue and White Scholastic Foundation, Inc., shall accompany all Applications.
- 4) An essay, written by the Applicant, telling about themselves and the reason for his or her desire to become a student at Pius X High School or Our Lady of Mt. Carmel, or I.C.S., shall accompany all Application (Approximately 300 words, doubled spaced.).
